Suggested Responses to Distressed or Distressing Behavior during Class: A Guide for Faculty

The chart below was created based on commonly asked questions regarding student behavior received in UK's Dean of Students Office. This chart is meant to serve as a guide only. The Center for the Enhancement of Learning and Teaching (CELT) https://www.ukv.edu/celt/ is another resource for instructors to discuss proactive strategies to prevent or mitigate incivility.

Action of Concern: Classroom Behavior	Recommended Response
Student is inappropriately using cell phone, tablet, computer, etc. during class	Include technology policy in syllabus, ask to speak with student after class.
Student is disrespectful when disagreeing with peers and/or instructor	Calmly remind students that the university welcomes diverse opinions, but that civility is key
Student refuses to participate	Ask to speak with student after class; contact CELT for strategies to increase student participation.
Student curses at or threatens peers and/or instructor	* Ask the student to leave the class; contact the Office of Student Conduct ¹ ; refer to the Center for Support and Intervention
Actions of Concern: Substance Abuse, Mental Health, and Reports of Violence	Recommended Response
Student appears to be under the influence of alcohol or drugs	**Ask the student to leave the class OR ask to speak with student after class. Additionally, contact the Office of Student Conduct.
Student is not maintaining self-care (Showering, brushing teeth, etc. Faculty has a concern about a student's mental health but is not sure how to reach out to the student	Speak with student after class and/or refer to the Center for Support and Intervention
Faculty has a concern about a student's mental health but is not sure how to reach out to the student	Contact the Center for Support and Intervention for guidance on approaching the student with an ethic of care and accountability
Student expresses current thoughts to harm self in a paper, email, etc.	*Respond to student with immediate resources - UKPD, UKCC, Suicide Prevention Lifeline 1-800-273-TALK (8255) etc and refer to the Center for Support and Intervention
Student discloses that they or someone they know is experiencing hazing	Contact the office of Student Conduct or the Center for Support and Intervention
Student discloses that they or someone they know has experienced violence	Contact the office of Student Conduct or the Center for Support and Intervention
Student discloses that they or someone they know is being stalked, or has been sexually assaulted, or is experiencing dating or domestic violence	Faculty are required to contact the Title IX Coordinator or report sexual misconduct, dating violence and domestic violence to the Office of Student Conduct. Faculty cannot promise to maintain a student's confidence regarding sexual misconduct, dating violence or domestic violence but can promise privacy. In addition to reporting their knowledge to the Title IX Coordinator, faculty should also refer students to the VIP (https://www.uky.edu/vipcenter/)

*Contact UKPD immediately anytime an active threat of harm is made 859-257-8573

Setting Standards for Classroom Decorum and Behavior Begins in the Syllabus

Faculty should be explicit in the syllabus in defining expectations about classroom behavior, classroom participation, class attendance, and civil discourse. Additionally, if the faculty member has standards and expectations related to the use of technology (earbuds, cell phones, tablets, laptops, etc.) in the classroom, these guidelines should be clearly articulated in the course syllabus. Any such policy must provide for reasonable exceptions. If the faculty member has standards and expectations for food and beverage within the classroom, these guidelines should also be clearly articulated in the course syllabus.

Outlining Consequences for Violating Classroom Decorum and Behavior Standards

To create a learning environment characterized by civility, faculty should begin by articulating clear expectations for student decorum and behavior in both the syllabus and in class. Consequences for violating classroom behavior standards could include participation point deduction, treating violations as an "unexcused absence", and/or reduction of the student's final grade. The syllabus must clearly identify/define the amount of reduction for a violation. Faculty who reduce a student's grade based on violation of classroom behavior policies should maintain records of the date and nature of any such violation.
